The school will follow syllabus 4. and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.

The school will follow the RTE Act, 2009 and instructions issued thereon by the 5. CBSE/Respective State /UT Govt from time to time.

The school will enroll students proportionate to the facilities available in the school as prescriped in the Affiliation Bye-Laws of the Board which shall not in general exceed the 6. optimum number as under from Pre-Primary to Class XII:
